Update on progress of our Green Minute

Plymouth Monthly Meeting is in unity to, in a step by step process, stop its use of fossil fuels to generate the electricity it uses to heat its water, to prepare its food, to heat its building, and to invest its funds. This commitment was made today, Sixth Month, 16, 2019, with the expectation that with prayerful discernment and Divine assistance, it will be completed in the next ten years. The implementation of this minute will require the work of the Property, House/Kitchen, Finance, and Trustee committees. It is requested that each of these committees prepare a plan for implementation of this minute for the areas of their responsibility.



This past year the property committee has completed the installation of a new electrical sub panel which enabled the installation of a tankless electric water heater and two electric car charger stations. More will be published on how to use the car charging stations next month. These additions and their changes to the energy use at the Meeting House are part of the property committee's responsibility to our Green minute. Future changes are being investigated for the electric supplier to provide using alternative energy sources, the replacement of our gas stove, and eventually the gas furnace. Finance committee is actively reviewing our investments to determine a path to moving them to a green portfolio. This change is in the beginning stage of investigation.

The green minute has an outreach component to share the learnings of the Monthly Meeting with its members and the wider community. Look to future newsletter articles about car charging, heating the buildings, financial investment etc. As we learn about these topics the knowledge will be shared with Abington Quarter and the Monthly Meeting so that individuals can use the information in their personal decisions about energy use, transportation and investments.

Each of us need to make informed decisions about our energy use according to our unique individual circumstances. As the changes in climate accumulate and accelerate each change, we can make is additive As a community with support and sharing of our knowledge we can make a difference.

Cash Bail update

Over the past year our Monthly Meeting and our Quarterly Meeting have been educating our selves on how the cash bail system affects low income people who have been arrested in Montgomery county for non-violent crimes. Statistics provided by the Montgomery County Public defender's office show that in regions without cash bail those accused of minor offenses show up for their preliminary hearings about 90% of the time despite having posted no cash bail. Here in Montgomery County low-income citizens who are unable to post \$500 cash bail are placed in the county jail system. They may remain there for months while the trial date is set. The unnecessary incarceration has an impact on their spouse and children of the family, employment, and financial stability of the family (sometimes transitioning the family to homelessness because of lack of income to pay rent). As with surrounding communities there is a desire to move to a non-cash-bail system for nonviolent offenders. There has been an effort by the Montgomery county Public Defender to provide information to our County officials to educate them about how the cash bail system can be changed for non-violent offenders.

Changes that make our justice system more efficient and less costly by placing less people in jail. Simple changes such as upgrading the way people are contacted by the court system about their obligations to future court hearings. This last issue of not establishing reliable communication was identified as a major cause for people not showing up to required court hearings.

Representatives of the Montgomery County public defender's office has been speaking with Montgomery county Commissioners, Judiciary, citizen organizations, and religious institutions over the past several years about this issue. On March February 25th the Montgomery County's public defenders, chief Dean Beer and deputy chief Keisha Hudson, were fired after filing amicus brief about the cash bail system. Two questions from these events are:

- How much independence does the Montgomery County public defender's office have to advocate on behalf of their clients?
- What is Montgomery County's intention for continued reform of the cash bail system?

It is important that our elected official hear from us. Keep in mind that there is always more to an event than is made public. It is important for citizens to request clarity in a persistent and respectful way. The failings of the cash bond system have been clearly identified both by individual cases and larger statistical analysis. How will our County address the issues that were listed in the amicus brief?
